**NOTIFICATION**

In exercise of the power conferred by the proviso to Rule 3 of the Business of the Government of Arunachal Pradesh (Allocation) Rules, 2021, the Governor of Arunachal Pradesh is pleased to make the following rules further to amend the schedule to the Business of the Government of Arunachal Pradesh (Allocation) Rules, 2021, namely;

1. Short Title, Extent and Commencement:

- i. These rules may be called The Business of the Government of Arunachal Pradesh (Allocation) (1<sup>st</sup> Amendment to the Schedule) Rules, 2025.
- ii. They shall come into force with immediate effect.

2. In the Schedule to the Business of the Government of Arunachal Pradesh (Allocation) Rules, 2021:

- i. In item No. 26, under the heading **"Department of Public Works"**, after entry at Sl. '(x)', the following entry shall be inserted as Sl. (xi) , namely:-

"Construction and maintenance of all the Civil and other Deposit works of Chief Estate Office, District Administration, Legislative Assembly, Public Works Department, DoKAA, Elementary Education, Secondary Education, Higher & Technical Education, Civil Aviation, Administrative Training Institute, Sports and Youth Affairs."

The existing entry at Sl. "(x) All CSS matter pertaining to the Department." Shall be re-entered at Sl. (xii).

- ii. In item No. 33, under the heading **"Department of Urban Affairs"** with its sub heading **"(A) Urban Development"**, after entry at Sl. '(xi)', the following entry shall be inserted as Sl. (xii), namely:-

"Constructions and maintenance of all the Civil and other Deposit works of the Department of Cooperation, Directorate of Transport, Industries, Law & Judicial, Finance, Planning & Investment, Public Libraries, State Transport, Town Planning & ULB, Trade & Commerce, Urban Development & Housing,

Science & Technology & Remote Sensing, Skill Development & Entrepreneurship and Research.”

The existing entry at Sl. “(xii) All CSS matter pertaining to the Department.” Shall be re-entered at Sl. (xiii).

- iii. In item No. 28, under the heading “ **Department of Rural Works**” with its sub heading “**(C) Building**”, after entry at Sl. ‘(ii)’, the following entry shall be inserted as Sl. (iii) , namely:-

“Construction and maintenance of all the Civil and other Deposit works of the Department of Labour & Employment, Land Management, Indigenous Affairs, Social Justice & Empowerment and Tribal Affairs (Except: CSS works will be as per The Business of the Government of Arunachal Pradesh (Allocation) Rules, 2021, amended), Textile & Handicrafts, Tourism, Tax & Excise, Economics & Statistics and Geology & Mining.”

- iv. In item No. 25, under the heading “**Department of Public Health Engineering & Water Supply**”, for the existing entry at Sl. ‘(ix)’,

“**Nodal Agency for undertaking civil construction works including operation & Maintenance under Health Department**”, the entry “**Constructions and maintenance of all the Civil and other Deposit works of the Department of Health Services and Public Health Engineering & Water Supply**”, shall be substituted.

- v. In item No. 16, under the heading “ **Department of Water Resources**” after entry at Sl. ‘(xiv)’, the following entry shall be inserted as Sl. (xv), namely:-

“Construction and maintenance of all the Civil and other Deposit works of the Department of Agriculture, Animal Husbandry, Veterinary and Dairy Development, Fisheries, Horticulture, DoTCL, Disaster Management, Food & Civil Supplies, Legal Metrology, Consumer Affairs, Water Resources Department (WRD).”

The existing entry at Sl. “(xv) All CSS matter pertaining to the Department.” Shall be re-entered at Sl. (xvi).

- vi. In item No. 24, under the heading “**Department of Power and Non-Conventional Energy Resources**” with its sub heading “**(A) Power Development**”, for the existing entry at Sl. ‘(viii)’,

**“Construction of residential and non-residential buildings of Electrical Department including their maintenance”, the entry “Constructions and maintenance of all the Civil and other Deposit works of the Department of Power and Non-Conventional Energy Resources”, shall be substituted.**

- vii. In item No. 24, under the heading **“Department of Power and Non-Conventional Energy Resources”** with its sub heading **“(B) Hydro Power Development”**, after entry at Sl. ‘(iv)’, the following entry shall be inserted as Sl. (v), namely:-

“ (v) Construction and maintenance of all the Civil and other Deposit works of the Department of Hydro Power, Road Safety, Small Savings, Art & Culture, Information & Public Relations, Information Technology and Printing.”

The existing entry at Sl. “(v) All CSS matters pertaining to the Department” shall be re entered at Sl. (vi).

- viii. In item No. 27, under the heading **“Department of Rural Development and Panchayati Raj”** with its sub heading **“(A) Rural Development”**, after entry at Sl. ‘(xiii)’, the following entry shall be inserted as Sl. (xiv), namely:-

“Construction and maintenance of all the Civil and other Deposit works of the Department of Rural Development and Women & Child Development (WCD).”

The existing entry at Sl. “(xiv) All CSS matters pertaining to the Department” shall be re entered at Sl. (xv).

- ix. In item No. 27, under the heading **“Department of Rural Development and Panchayati Raj”** with its sub heading **“(B) Panchayati Raj”**, after entry at Sl. ‘(xi)’, the following entry shall be inserted as Sl. (xii) , namely:-

“Construction and maintenance of all the Civil and other Deposit works of the Department of Panchayati Raj.”

The existing entry at Sl. “(xii) All CSS matters pertaining to the Department” shall be re entered at Sl. (xiii).

- x. In item No. 24, under the heading **“Department of Power and Non-Conventional Energy Resources”** after its sub heading **“(C) Non-Convention Energy Resources”** with its entries, the

following sub heading, **“(D) Arunachal Pradesh Energy Development Agency (APEDA)”**, shall be inserted with the following entry at Sl. (i),

“Construction and maintenance of all the Civil and other Deposit works of the Arunachal Pradesh Energy Development Agency.”

- xi. In item No. 9, under the heading **“Department of Environment & Forest”** with its sub heading **“(A) Forest”**, for the existing entry at Sl. ‘(xi)’,

**“Construction of approach roads, buildings of Forest Department”,** the entry **“Constructions and maintenance of all the Civil and other Deposit works of the Department of Environment & Forests & Climate Change”**, shall be substituted.

- xii. In item No. 13, under the heading **“Department of Home, Border Affairs and Political”** after its sub heading **“(B) Political”** with its entries, the following sub heading, **“(C) Police Housing”**, shall be inserted with the following entry at Sl. (i)

“Construction and maintenance of all the Civil and other Deposit works of the Department of Home (Police Housing), Prison and Correctional Administration and Fire and Emergencies Services.”
